MUNICIPAL ELECTIONS 2010

TOWNS OF MIDLAND, PENETANGUISHENE & TOWNSHIPS OF TAY & TINY

Municipal Elections will be held in October 2010*. The term of office will be December 1, 2010, to November 30, 2014.

Notice is hereby given that as of January 4, 2010 (1st day the office is open in the election year); Nominations may be filed in person, or by an agent, in the Clerk's Office during normal office hours prior to Nomination Day and between 9:00 A.M. and 2:00 P.M. on Nomination Day, Friday, September 10, 2010*. (* pending royal assent of Bill 212)

Nominations must be submitted on the prescribed form (available at any of the Municipal Offices), signed by the person being nominated and must be accompanied by the prescribed nomination filing fee (\$200 for Head of Council and \$100 for all other offices).

Information as to qualifications for candidates can be obtained at any of the Municipal Offices.

If you plan to seek office in the 2010 Municipal Elections for Municipal Council or School Trustee, you must file a Nomination Paper with the respective Municipal Clerk before accepting contributions or spending money on your campaign.

The offices for which persons may be nominated are:

- **TOWN OF MIDLAND (575 Dominion Ave):**
 - MAYOR** – 1 to be elected (at large)

 - COUNCILLOR, Ward 1** – 3 to be elected

- **TOWN OF PENETANGUISHENE (10 Robert Street West):**
 - MAYOR** – 1 to be elected (at large)

 - COUNCILLOR, Ward 2** – 4 to be elected
